No.GTH/2019/10/MKM/12/2015/41/A:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Assistant Director, class II (Departmental Examination) Rules, 2016, namely:-

1. These rules may be called the Assistant Director, class II (Departmental Examination) (Amendment) Rules, 2019.
2. In the Assistant Director, class II (Departmental Examination) Rules, 2016, (hereinafter referred to as 'the said Rules'), in rule 2, for clause (c), the following clause shall be substituted, namely:-  
“(c) “Institute” means the Sardar Patel Institute of Public Administration (SPIPA) or such institute as may be notified by the Government”.
3. In the said Rules, wherever the word “Board” occurs, the word “Institute” shall be substituted.
4. In the said rules, in rule 4, for sub-rule (1), the following sub-rule shall be substituted, namely:-  
“(1) The papers and syllabus of the relevant examination shall be as specified in the Appendix 'A'. The examination of Paper I, II, III and IV shall consist of multiple choice questions through OMR Sheet/Online mode or in such other mode as may be decided by the Institute. The examination for Paper V and VI shall be descriptive type and Paper VII shall be practical test.”.
