No. GTH-2018-29-PTL-102015-9-B: In exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955), read with the Order of Government of India, Ministry of Petroleum and Natural Gas No. G.S.R. 729(E), dated the 19th December, 2005, the Government of Gujarat hereby makes the following order further to amend the Gujarat Essential Articles (Licensing, Control and Stock-Declaration) Order, 1981, namely :-

1. (i) This order may be called the Gujarat Essential Articles (Licensing, Control and Stock-Declaration) (Amendment) Order, 2018.
(ii) It shall come into force at once.
2. In the Gujarat Essential Articles (Licensing, Control and Stock Declaration) Order, 1981 in Schedule-I, in Part-II, under the heading Other than Food stuff, under item “(2) Petroleum products namely:” entry (c) high speed diesel oil, and entry (d) **** Petrol, shall be deleted.
